HIDDEN PROBLEMS FOR LANDLORDS

Those of you listening to the Queen's Speech with bemusement at her announcement of future charges for plastic bags may not be aware that she also gave Royal Assent on 14 May 2014 to the new Immigration Act. This introduces provisions which require private landlords of residential properties to check the immigration status of their tenants.

This obligation is not simply to check that the tenants have a right to be in this country at the start of the tenancy. The Landlord must also make sure that that right does not lapse during the tenancies term. Falling foul of the regulations could lead to a fine of up to £3,000!

It is hoped that the scheme will be piloted before the regulations are brought into full effect but Landlords be warned.

News that the Passport Office is experiencing unprecedented delays and levels of demand for new passports has led ministers to recommend Britons to indulge in "staycations". This is not news but a new craze for renting properties direct from their owners has also been hinted at in recent weeks.

THE TIMES THEY ARE A CHANGING

It has recently been announced that from 30 June 2014 Land Registry will no longer require originals of Transfer documents to be supplied to them on applications for registration. This announcement signifies a further move towards econveyancing and it is already now possible to apply for registration of Transfers of Title online. The fees for doing this are half the price of the paper version and, with a few initial teething problems, the system seems to be working fairly well. Obviously those who were opposed to dematerialisation of Title Deeds and the abolition of Land and Charge Certificates will consider this to be a further retrograde step and it is possible that fraudsters are rubbing their hands in glee. We would remind our readers that it is extremely important to keep your address for service registered in the Land Registry (of which you can have up to three) up to date so that you receive information on any activities on your properties. Properties that are not subject to a mortgage are particularly vulnerable and land owners resident overseas can also be a target. What will happen if/when the Land Registry is privatised is anyone's guess, huge potential for fraud. Lobby your MP!
